For the 1/5 water remediation project work behind the elevator in 1/5 is completed. Another project to bury the drain in front of 1/5 will happen sooner than later, no exact date known, probably June. There is a muddy patch of yard at the northeast corner of the building that will be temporarily covered by turf. Suggested to include money for a retaining wall for next year's budget.
- Landscaping plans: Fencing to stop pedestrian trespassing behind 10/14 will be installed. Steve can do it for under \$150. Also plan to plant raspberry bushes along the fencing. \$50-\$60 if we want to block off the area by BMO bank. Owner has suggested adding vegetable boxes for growing our own food. If people are interested they should form a committee and come up with a plan to present to the Board.
- **Bylaws:** Continue to be in discussion with the attorney. Will discuss at the next Executive Meeting.
